On the Global front, the displacement number is 79.5 million or one in every 97 people on the planet at the end of 2019. This number of forced displacement has almost doubled since 2010 (41 million). It should be noted that this figure is the highest since these statistics have been systematically collected. It is approximately 1% of the world's population.
